Non-Profit Vendor: To receive the non-profit price, you must provide a copy of your non-profit ID, as well as only participate in the festival as an informational vendor. If you are non-profit but would like to sell items, then you must check the "Non-profit Vendor Sales" category.

INDEMNIFICATION

Vendor shall indemnify, defend, and hold harmless the Imperial Valley Regional Chamber of Commerce, its officers, officials, employees, agents, and volunteers from any and all losses, costs, expenses, claims, liabilities, actions or damages, including liability for injuries or illnesses including communicable diseases to any person(s), or damage to property arising at any time during and/or arising out of or in any way connected with vendor's participation in 2023 Christmas in July events unless solely caused by the gross negligence or willful misconduct of the Imperial Valley Regional Chamber of Commerce, its officers, officials, employees, agents, or volunteers.

INSURANCE REQUIREMENTS

Vendor shall procure and maintain commercial general liability insurance with coverage at least as broad as Insurance Services Office form CG 00 01, in an amount not less than \$1,000,000 per occurrence, \$2,000,000 general aggregate for bodily injury, personal injury, and property damage. The Imperial Valley Regional Chamber of Commerce, its officers, officials, employees, agents, and volunteers shall be additional insureds under such policy. Coverage provided by the vendor shall be primary and any insurance or self-insured procured or maintained by the Imperial Valley Regional Chamber of Commerce shall not be required to contribute with it. If alcohol will be sold by the vendor, coverage must include full liquor liability.
